

Copyright Guidelines - Putting Readings Online

These guidelines are intended to assist academic and library staff to make readings available online for students.

The educational statutory licence in section 113P Copyright Act determines what material may be reproduced and distributed in books of readings, handed out in class, or made available online for students, without seeking permission from the copyright owners. The licence stipulates that educational institutions may reproduce and communicate copyright material for the educational purpose of the institution so long as they make payments to the copyright owners by means of a remuneration agreement with the Copyright Agency Limited (CAL).

Making material available online is subject to much stricter conditions than is distribution of paper copies. There are narrower limits on quantities; access must be restricted to QUT staff and students only; detailed records must be kept; and a prescribed warning notice must be attached to the copies. To enable staff to comply, the University has established QUT Readings.

The statutory licence does not apply to material acquired under licence agreements with the copyright owners, such as the journal databases like Proquest and ScienceDirect. The University deals with these in accordance with the agreements, which usually do not permit reproducing the articles on University websites.

Academic and Library staff wanting to digitise readings must submit a request through [QUT Readings](#). QUT Readings staff will retrieve and scan the requested material, convert it to a PDF document, attach the legally required warning notice, and make it available online through QUT Blackboard for your course unit. If the request is for an article from a licensed database, QUT Readings staff will make a reliable link to the article on the vendor website if technically possible.

It is permitted to post copyright material to school or faculty websites or to a QUT Blackboard site under [certain circumstances](#).

The table following gives details of what may be copied and put online under this licence. There are two components to the licence – the hardcopy scheme and the electronic scheme. The term “hardcopy” covers paper, video and audio tape, film, transparencies, etc. There are slight differences as to what can be copied, depending on the format of the original. The table is organised according to the categories used in the Copyright Act.
